# 「Seoul Foreign Business Day 2018」

# Citation ceremony for great contributions to foreign investment

The Seoul Metropolitan Government will receive a recommendation from the following persons in order to award for great contributions to the economic development and job creation of Seoul through the inducement of foreign investment and to award the foreign invested company (institution/individual) as a model for others through social contribution.

2018. 7. 10. Mayor of Seoul

- 1. Award areas : Total 3 areas (Investment promotion, Job creation, Corporate social responsibility)
- 2. Number of citations: Maximum 3 companies or persons in each areas
- 3. Contents: Plaque(Commendation of Mayor of Seoul)
- 4. Recommendation guide
  - 1) Eligible nominee (Individual·Group): Foreign Investment Company,
    Foreign Chamber of Commerce in Korea, Kotra · Law firm ·
    Accounting corporation ·Association, and relevant organizations, etc.
    - (Investment promotion) Those who have proven their contribution to the economic and social development of Seoul through foreign direct investment
      - subject
        - ① Foreign Investment Company(Group): Those who contributed to the economic

- development of the city by investing more than US \$ 1 million in foreign investment in the past two years
- Recognition subject and Scope of Investment Performance: According to the arrival (or payment) standard, KOTRA and foreign exchange bank are confirmed by the "Foreign Investment Statistics System" entered by the administrator
- ② Relevant organizations(Organizations Individual) : Any person directly or indirectly contributing to foreign direct investment in Seoul
  - Contribution of investment attraction (to find potential companies, to support investment, to support investment promotion team)
  - Support performance of Investment Promotion (Investment promotion environment and system improvement activities, investment consultation and grievance processing support, investment attraction conference held in Seoul, performance of seminar attendance, etc.)
- (Job creation) Those who contributed to the creation of employment in our city during the investment period calculation period
  - Subject : Foreign-invested companies only
- (Corporate social responsibility) A person who contributed greatly to the improvement of the living environment of Seoul and the disparity of social inequality through social contribution activities such as providing education opportunities and supporting the vulnerable class.
  - Subject : Foreign-invested companies, relevant organizations (organizations, individuals)
- Period of public evaluation including investment performance : 2016.7.01. ~ 2018.6.31.

#### 2) Valuation exclusion

- Winner of the Mayor's Commendation for the same achievement
- Those who received awards from the mayor or ministerial level within the past two years (based on the deadline for submitting documents (10.1))

- \* However, in case of winning career such as contests, exception
- Those who have been under investigation or have been sentenced to criminal prosecution (confirmed by fact investigation)
  - A person under investigation or being prosecuted for a criminal trial
  - A person who has been sentenced to imprisonment for 3 years or less and has not received a sentence of over 4 years
  - A person who imprisonment for 3 years or less and in grace period less than 2 years or one year in jail
  - Those who have been fined more than 2 times or over 2 million won in three years
- Exclusion from violation of relevant law
  - Workplaces and their officers whose names have been announced in relation to industrial accidents, etc., under the Industrial Safety and Health Act
  - Incorporated corporation and its officers who violate Fair Trade Act
  - In the past three years, the payment of wages and relevant names have been disclosed or information has been provided to the credit information agency.
  - Those whose names are public due to high delinquency
  - Those who are judged not to be worthy of recognition because they have caused controversy due to other moral defects or social punishment

#### Recommendation Procedures

- 1) Recommender: Head of business department of Seoul city, Director of relevant organizations, group or person
  - \* When an individual recommends a nominee for awards, he or she must be at least 19 years old and 10 or more.
  - Recommender of the department affiliated to the business department is recommended by the head of business department
